- Anxiety, stress or depression.
- Pre-existing Medical Conditions or any ongoing medical condition.
- Unemployment other than redundancy.
- Loss or damage from any unattended venue or vehicle.
- Contracts which were/are not in writing.
- Damage to underground services.
- Damage to any flooring caused by footwear of any kind.
- Any wilful or malicious act, any act of vandalism.
- Deliberate acts resulting in material damage or bodily injury.
- Circumstances of which you are aware at the time of effecting this insurance

Policy excess applies to Public Liability, Marquee and Contents or Ceremonial Sword Sections only. All other sections have NO policy excess deductible.

Summary of cover

cancellation or curtailment & rearrangement

Irrecoverable expenses, including rearrangement, incurred as a result of the unavoidable and unexpected cancellation or curtailment of the wedding or reception due to any cause beyond your control but not extending to:

- The disinclination of the bride or groom to marry
- Lack of funds other than through redundancy
- Pregnancy or child birth
- Stress suffered by the bride or groom
- Any circumstances known at the time of the policy issue

ceremonial attire - bridal attire

We will pay for loss or damage to wedding outfits belonging or hired to the wedding party. (Wedding Party is the bride, groom, their parents or guardians, bride's attendants, best man and ushers.)

photographs and videos

We will pay the cost of retaking the wedding photographs or video following the failure of the professional photographer to turn up, or the total loss or non-development of the original film, negative or video.

wedding rings

We will pay for loss or damage for up to 7 days prior to the wedding & up to 24 hours after the reception whilst at home, at the reception or in transit.
